## COUNCIL/COMMITTEE COMMENTS

## <u>Councilman Haynes – Public Utility and Works Committee</u>

Department of Public Works – Councilman Haynes reported that the Department of Public Works has planted new trees at Friendship Field. Weekly toolbox talks are being held regarding Covid-19 and PPE is continuing to be provided as available. The new guardrail has been installed on Jackson Avenue and the tree sapling handout scheduled for May has been cancelled.

# Councilman McDonald – Personnel Committee

Recreation – Councilman McDonald reported that the Recreation Director is continuing to work on outside projects and is coordinating with various groups to ensure that all seniors are receiving what they need during the pandemic.

## Councilman Greuter - Public Safety Committee

*Police Department* - Councilman Greuter reported that the Police Department made 4 arrests and issued 55 summonses during the month of March. All non-emergency incident reports are being taken over the phone.

# **ORDINANCE NO. 02-20**

# ORDINANCE OF THE BOROUGH OF ROCKAWAY MAYOR AND COUNCIL AMENDING CHAPTER A263, FEES, OF THE CODE OF THE BOROUGH OF ROCKAWAY

WHEREAS, the Mayor and Council of the Borough of Rockaway have determined that a need exists for certain fees charged under Chapter A263, Fees, Section A263-1, Fees established, Item R, Chapter 217, Streets and Sidewalks, of the Code of Ordinances of the Borough of Rockaway to be amended in order to better reflect the actual costs of the relevant services.

**Now, Therefore Be it Ordained** by the Mayor and Council of the Borough of Rockaway, County of Morris, State of New Jersey, that the following amendments be made to the Code of the Borough of Rockaway:

# Section I - Chapter A263, Fees

- 1. Chapter A263, Fees, Section A263-1, Fees established, Subsection R is hereby repealed in entirety and modified to read as follows:
  - "R. Chapter 217, Streets and Sidewalks.
    - (1) The fee to obtain permission to open, dig up, excavate, or disturb any street or portion thereof shall be \$100 for any residential property and \$400 for any commercial property.

- (2) Escrow fees will be as follows:
  - a. For all openings up to 100 square feet: \$450.
  - b. For all openings from 100 to 1,000 square feet: \$1,000.
  - c. For all openings greater than 1,000 square feet, the escrow fee will be determined based upon location of the work, construction schedule, restoration cost estimate, and the scope of work proposed. Full-time construction observation and reimbursement will be required for all projects determined to be of a nature that could impact the infrastructure of the Borough of Rockaway. This determination will be based upon the recommendation of the Borough Engineer after careful review of the application and concurrence by the Borough Administrator and the Superintendent of the Department of Public Works."

## Section II

- 1. This Ordinance may be renumbered for codification purposes.
- 2. Severability. The provisions of this ordinance are hereby declared to be severable. Should any section, paragraph, subparagraph, provision, sentence, or part hereof be declared invalid or unconstitutional, said finding shall not affect any other section, paragraph, subparagraph, provision, sentence, or part thereof.
- 3. Repealer. All ordinances or parts of ordinances of the Borough of Rockaway which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- 4. Prior Actions. All actions of the Borough of Rockaway taken prior to the date of adoption hereof contemplated by this Ordinance are hereby ratified and approved.
- 5. Effective Date. This Ordinance shall take effect immediately upon final passage and publication according to law.

# ORDINANCE NO. 03-20, Public Hearing & Adoption

# **ORDINANCE NO. 03-20**

ORDINANCE OF THE BOROUGH OF ROCKAWAY
MAYOR AND COUNCIL
AMENDING CHAPTER 217, STREETS AND SIDEWALKS
OF THE CODE OF THE BOROUGH OF ROCKAWAY

**WHEREAS**, the Mayor and Council of the Borough of Rockaway have determined that a need exists for a two-year moratorium following paving.

**NOW, THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Rockaway, County of Morris, State of New Jersey, that the following amendments be made to the Code of the Borough of Rockaway:

# Section I – Chapter 217, Streets and Sidewalks

1. Chapter 217, Streets and Sidewalks, Subsection 217-28, Two-Year Moratorium, is hereby added to read as follows:

"217-28, Two-Year Moratorium Following Paving.

- Prior to the start of any paving or repaving work on any Borough road, street or Borough-controlled right-of-way, the Director of Public Works or the Borough Engineer shall notify each utility company, resident, and business impacted by paving or repaving work of said work so any excavations, trench and patch repairs may be completed before paving is started. Such notice shall provide that no excavation permit shall be issued for openings, cuts, or excavations in said street for a period of two years from the date of such paving unless appropriate pavement restoration requirements are met. The notice shall also provide that applications for excavation permits for work to be done prior to such paving or repaving shall be submitted promptly so that any work may be completed not later than 90 days from the date of such notification.
- 2. During such two-year period, any permit issued to open, cut, or excavate in such a Borough road, street or Borough-controlled right-of-way shall require a road opening permit in accordance with § 217-11. Additionally, the Director of Public Works or the Borough Engineer shall ensure that any street opening on any Borough road, street or Borough-controlled right-of-way paved within two years is restored satisfactorily using appropriate pavement restoration methods to include milling and paving, infrared pavement restoration, or any other acceptable pavement restoration technology approved by the Borough Engineer.
- 3. The distances of pavement restoration in either direction of the opening will be determined by the Borough Engineer and Superintendent of Public Works based on proximity to other Borough roads, streets or Borough-controlled rights-of-way or utility concerns.
- 4. Proof of insurance. Any contractor hired to perform a street or roadway excavation in the Borough of Rockaway shall provide proof that it is licensed and bonded within the State of New Jersey.

#### **ORDINANCE NO. 04-20**

# ORDINANCE OF THE BOROUGH OF ROCKAWAY MAYOR AND COUNCIL AMENDING CHAPTER 183, PEACE AND GOOD ORDER, OF THE CODE OF THE BOROUGH OF ROCKAWAY

**WHEREAS**, the Mayor and Council of the Borough of Rockaway have determined that a need exists to amend Chapter 183, Peace and Good Order, Article III, Nuisance Noise, of the Borough of Rockaway.

**NOW, THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Rockaway, County of Morris, State of New Jersey, that the following amendments be made to the Code of the Borough of Rockaway:

# Section I - Chapter 183, Peace and Good Order

1. Chapter 183, Peace and Good Order, Article III, Nuisance Noise, has been modified to read as follows:

183-26. Definition of nuisance in the form of noise.

- A. Radios, televisions, phonographs, sound amplification devices. The playing, use or operation of any radio-receiving set, television, musical instrument, phonograph or other machine or device for the producing or reproducing of sound or amplification of sound in such manner as to disturb the peace, quiet and comfort of neighboring inhabitants or with louder volume than is necessary for convenient hearing for persons who are in the room, vehicle or chamber in which the machine or device is operated and who are voluntary listeners. The operation of such a set, instrument, phonograph, machine or device so that it is clearly or plainly audible at a distance of 100 feet from the building, structure or vehicle in which it is located between the hours of 11:00 pm and 7:00 am shall be prima facie evidence of a violation of this article.
- B. Yelling, shouting, whistling or singing that is clearly or plainly audible on the public streets between the hours of 11:00 pm and 7:00 am, or at any time or place, which annoys or disturbs the quiet, comfort or repose of persons in any office, dwelling, hotel, motel or other type of residence or of any persons in the vicinity on the public streets, at any time or place, which annoys or disturbs the quiet, comfort or repose of persons in any office, dwelling, hotel, motel or other type of residence or of any persons in the vicinity.
- F. Construction or repair. The exterior use or operation of motorized or mechanical construction equipment, machinery, tools or vehicles in connection with the performance of excavation, demolition, construction, repair or alteration work including the loading, unloading, delivery or pick-up of construction equipment, materials, boxes, crates, containers and the delivery and/or pick-up of any such equipment or materials, if such work generates noise that disturbs the peace, quiet, and comfort of neighboring inhabitants and is clearly or plainly audible at a distance of 100 feet from the building, structure or vehicle in which it is located, other than between the hours of 7:00 a.m. and 8:00 p.m. Monday through Friday, and 8:00 am and 8:00 pm Saturday and Sunday is prohibited. In the case of urgent necessity or in the interest of public health or safety, the Code Enforcement Officer may grant a permit for excavation, demolition, repair or alteration work for a period not to exceed three days, by the terms of which permit such work may be carried on between the hours of 8:00 p.m. to 7:00 a.m. Monday through Friday, 8:00 pm through 8:00 am Saturday and Sunday.

G. Landscaping-related equipment. No person shall operate or cause to be operated upon any property in a residential zone any motorized landscaping equipment, machinery, generators for nonemergency use, or power tools, including but not limited to power drills, sanders, grinders, leaf blowers, lawn mowers, or edgers, outdoors in a manner as to disturb the peace, quiet and comfort of neighboring inhabitants and that is clearly or plainly audible at a distance of 100 feet between the hours of 8:00 p.m. to 7:00 a.m. Monday through Friday, and 8:00 pm through 8:00 am Saturday and Sunday.

# 183-27. Exceptions.

Nothing herein shall be construed to apply to the following:

- A. Activities of municipal departments in the performance of their duties, drills or public demonstrations.
- B. Activities in public parks, playgrounds or public buildings under permission or authority of municipal officials, and activities at Fireman's Field under permission or authority of the Rockaway Fire Department.
- C. The playing by a band or orchestra I a hall or building or in the open air when duly authorized by the governing body or the Board of Education of the Borough.
- D. Activities sponsored by or authorized by any public board of education or governing body of any private school duly licenses by an agency of the State of New Jersey.
- E. Any agricultural-related activities taking place on any property qualifying for protections secured under the New Jersey Right to Farm Act (N.J.S.A. 4:1C-1 et seq.).
- F. Implements or machinery used in removal of snow or ice, such as snowblowers and snowplows.
- G. Emergency and standby generators.
- H. Road construction, maintenance and utility work as regulated in Article VIII, 217-71, Hours of road work, including the performance of any work by a public utility as defined in Title 48 of the Revised Statutes of New Jersey or to any employees of such public utility.

# 183-28. Enforcement.

Complaints for violations of any of the provisions of the Article are hereby authorized to be made by any individual person or resident, any member of the Rockaway Borough Police Department, the Code Enforcement Officer, Health Officer, or any other official or employee of the Borough.

#### 183-29. Violations and penalties.

Any person who shall be found to be in violation of any provision of this Article shall, upon conviction, be subject to a fine of not less than \$100 nor more than \$2,000. Each day any violation of any provision of this Article shall continue, shall constitute a separate offense.
