### MAYOR & COUNCIL REGULAR MEETING MAY 28, 2020 6:00 p.m.

The Regular Meeting of the Mayor and Council of the Borough of Rockaway, in the County of Morris, New Jersey, was held in the Community Center, 21-25 Union Street, Rockaway, N.J. with Mayor Thomas Mulligan presiding. Mayor Mulligan called the meeting to order at 6:00 p.m.

Mayor Mulligan read the following statement: In accordance with Section 5 of the Open Public Meetings Act, Chapter 231, Public Laws, 1975, be advised that notice of this meeting was made by posting on the Bulletin Board, Town Hall, and sending to the officially designated newspapers, a list of meeting dates annually, indicating that the meeting would take place at the Community Center at 6:00 p.m. on this date. Mayor Mulligan announced the location of the fire exits.

#### APPROVAL OF MINUTES

Upon motion by Councilman Greuter, seconded by Councilman McDonald, and carried unanimously upon voice vote, the minutes of the April 9, 2020 Regular Meeting and the April 23, 2020 Regular Meeting were accepted as submitted.

#### CORRESPONDENCE

Mayor Mulligan read a letter of resignation from Patricia L. Bussow, Borough Clerk/Administrator, effective June 19, 2020.

#### COUNCIL/COMMITTEE COMMENTS

Councilman McDonald - Personnel Committee

*Recreation* – Councilman McDonald reported that all Little League refunds have been processed; soccer and track refunds are now being worked on. Quotes are being obtaining for various projects and discussions are starting regarding fall sports.

*Personnel Committee* – The final copy of the job description for Community Liaison has been distributed to Mayor and Council for final review.

Councilman McDonald requested a closed session for personnel.

#### Councilman Haynes - Public Utility and Works Committee

Councilman Haynes reported that the Department of Public Works replaced a water hazard on Hoagland Avenue, retired an old water service, and completed the repair at the driveway at 21 Burton Lane. They are also in the process of replacing outdated fire hydrants and completing water main work on Elycroft Avenue prior to road resurfacing. A new water truck has been delivered and will be put into service once it is lettered.

*Board of Education* – Councilman Haynes reported that construction projects are underway at both Lincoln School and Thomas Jefferson School.

## Councilman Hurley - Finance and License Committee

Councilman Hurley reported that the 2019 Audit is in the final stages and the auditor will attend a meeting in the near future.

#### Councilman Greuter - Public Safety Committee

Councilman Greuter reported that interviews are underway for the new patrolman.

Councilman Greuter requested that the personnel policy be reviewed with regard to reimbursement of expenses for education when an employee leaves the Borough within two years of the completion of that education.

#### Councilwoman Burnside - Fire Committee

*Library* – Councilwoman Burnside reported that the library remains closed but the staff is very active on Facebook.

*Board of Health* – Councilwoman Burnside reported that there were no new Covid-19 cases reported in Rockaway Borough during the last week.

# **RESOLUTION 79-20:** AWARD CONTRACT (DENTAL, SHORT-TERM DISABILITY, LONG-TERM DISABILITY, AND LIFE INSURANCE FOR FULL-TIME EMPLOYEES)

WHEREAS, the Borough of Rockaway desires to provide dental, short-term disability, long-term disability, and life insurance coverage for its full-time employees; and

WHEREAS, MetLife, 4150 N. Mulberry Drive, Suite 300, Kansas City, MO 64116 (800-624-4071), provides such insurance coverage; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq) provides that any contract the amount of which exceeds the bid threshold, may be negotiated and awarded by the governing body without public advertising for bids and bidding therefor and shall be awarded by resolution of the governing body if the subject matter thereof consists of insurance, including the purchase of insurance coverage and consultant services, which exception shall be in accordance with the requirements for extraordinary unspecifiable services; and

WHEREAS, a Certificate of Availability of Funds has been filed by the Borough of Rockaway Chief Financial Officer; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq) requires that a resolution authorizing the payment of such fees without competitive bidding must be publicly advertised.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Rockaway, County of Morris, State of New Jersey as follows:

- The Mayor and Borough Clerk are hereby authorized and directed to execute an agreement in an amount not to exceed \$156,288.00 with MetLife, 4150 N. Mulberry Drive, Suite 300, Kansas City, MO 64116 (800-624-4071) for dental, short-term disability, long-term disability, and life insurance for full-time employees, for the period July 1, 2020 through June 30, 2022.
- 2. This contract is awarded without competitive bidding as "Extraordinary, Unspecifiable Services" in accordance with the Local Public Contracts Law because the services required cannot be reasonably described by written specifications to assure that the qualitative and quantitative assessment of the problem involved, which require expertise, extensive training and proven reputation in the field of endeavor are obtained.
- 3. That a notice in accordance with this resolution and the Local Public Contracts Law of New Jersey, shall be published in the official newspaper or newspapers of the Borough of Rockaway as required by law.

#### **RESOLUTION 80-20:** AUTHORIZE SETTLEMENT AGREEMENT (ROCKAWAY GARDENS)

WHEREAS, a discrepancy arose as to the calculation of the charges on the water bill as a result of the upgrade and replacement of the previous water meter by the Borough with a different type of meter; and

**WHEREAS**, although it is the position of the Borough that it has the discretion to amend the ordinance at any time to change the manner in which charges are calculated to be consistent with that of how the new meter had been set in this instance or in any other way it may deem appropriate, that was not a change that was intended when the Borough made the decision to upgrade the existing water meters; and

WHEREAS, the Parties prefer to resolve the current issue amicably and without further risk or expense and wish to execute a settlement agreement;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Rockaway, in the County of Morris, State of New Jersey, that the Borough Clerk is hereby authorized to execute a settlement agreement with Robmar Realty Associates, LLC t/a Rockaway Gardens Apartments stating that the Borough will issue a total credit in the amount of \$13,741.77 to be applied to charges on Releasor's accounts. Such credit shall be applied to any charges on both Account No. 0100-00191 and 0100-00190 until the balance of the credit is exhausted.
